Betfair

We refer to your email of 23 December 2014, and have also seen your email of 8 January 2015.

As we have already explained, we are instructed by Betfair and its current employees only (which does not include Edward Wray or Anthony Clare).

Contrary to what you say, in our original letter of 28 November 2014 we very clearly set out the untrue and defamatory allegations that you have made. Should it assist, we can repeat ourselves: the untrue allegations you have made in the Emails and Document are that Betfair as a company and the Betfair legal team as individuals:

- have knowingly participated in and abetted criminal acts for the past 8 years;
- are responsible for billions of dollars of "wire fraud";
- are lying about such criminal activity and concealing it in a way which amounts to securities fraud;
- are defrauding Betfair's customers and investors of millions of pounds;
- are intentionally designing Betfair's policies so as to encourage and assist its customers to bet illegally;
- are knowingly taking illegal bets from the United States and other jurisdictions;
- are earning billions of dollars of commission from criminal activity and are illegally laundering this money by lying and falsely accounting for this as legal UK revenue;
- deliberately misled investors in the prospectus for Betfair's listing on the London Stock Exchange in October 2010 by lying and concealing that a significant portion of its revenue came from criminal activity.
