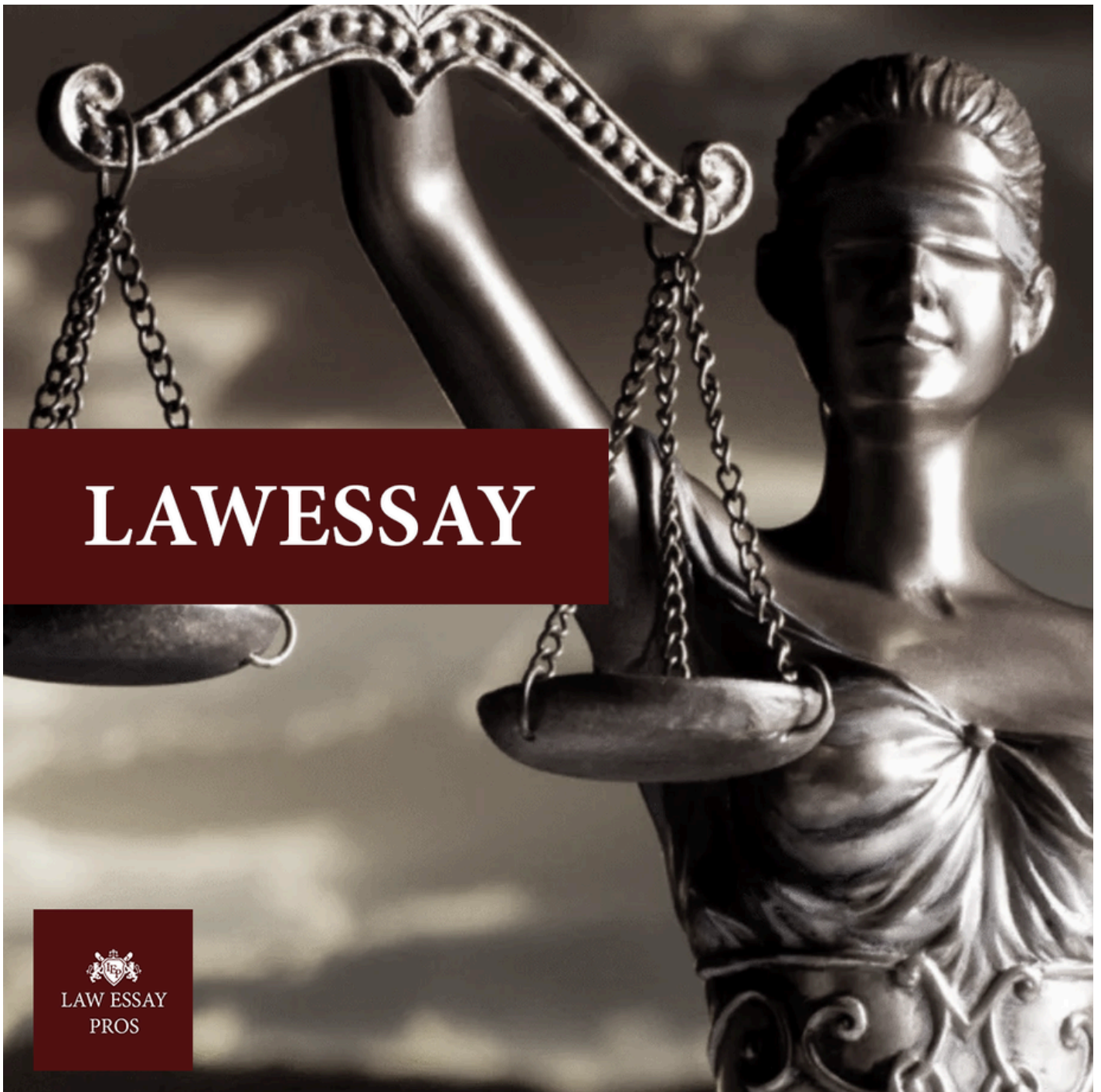




# WAYS TO OPTIMIZE YOUR RESEARCH SKILLS
