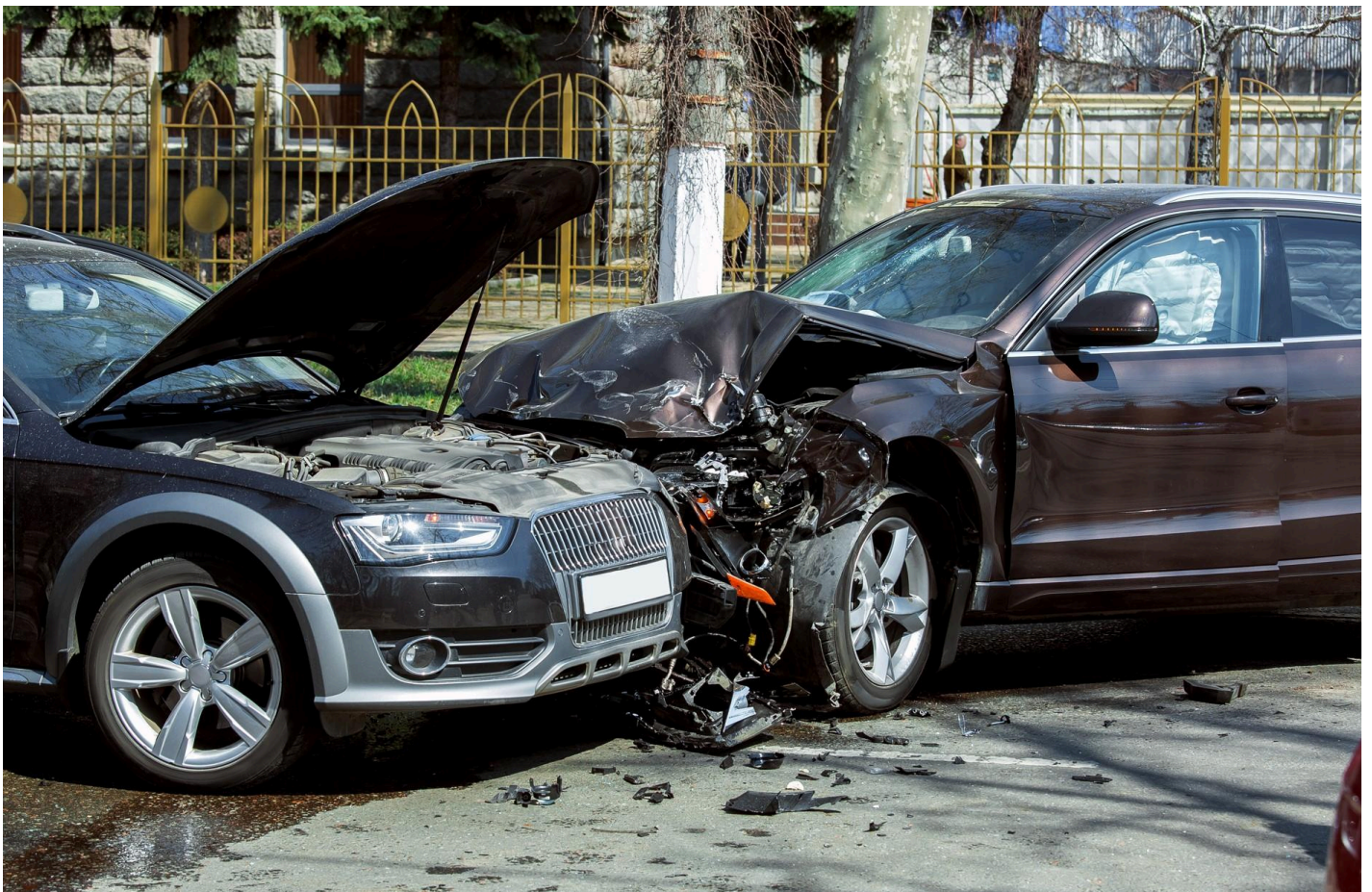

## **Distracted Driving**
