Type 20 License: This off-sale beer and wine license allows retailers, such as grocery and convenience stores, to sell packaged beer and wine for off-premises consumption. However, it does not permit the sale of open containers or on-site consumption. Additionally, businesses holding this license can allow minors on the premises without restrictions.

Type 21 License: This off-sale general license allows retailers to sell packaged beer, wine, and distilled spirits for off-premises consumption. It is ideal for liquor stores, grocery stores, and convenience stores looking to offer a full range of alcoholic beverages. Unlike the Type 20 license, which is limited to beer and wine, the Type 21 license includes distilled spirits. However, it does not permit on-site consumption or the sale of open containers, and there are no restrictions on minors being present in the store.

Type 47 License: Is an on-sale general license that allows restaurants to serve beer, wine, and distilled spirits for on-premises consumption. To qualify, the establishment must serve food and maintain a suitable kitchen, with at least 51% of sales coming from food. This license is more comprehensive and often more expensive than those for beer and wine alone, as it applies to full-service dining rather than bars or nightclubs.

Type 48 License: is for bars and nightclubs that serve alcohol to patrons aged 21 and older. Unlike the Type 47, it does not require food service and has strict regulations around entry—minors are not allowed. The application process is thorough, involving zoning laws and city regulations. The cost varies by location, with an application fee of \$15,835 and annual fees

ranging from \$790 to \$1,235 as of October 2024.
