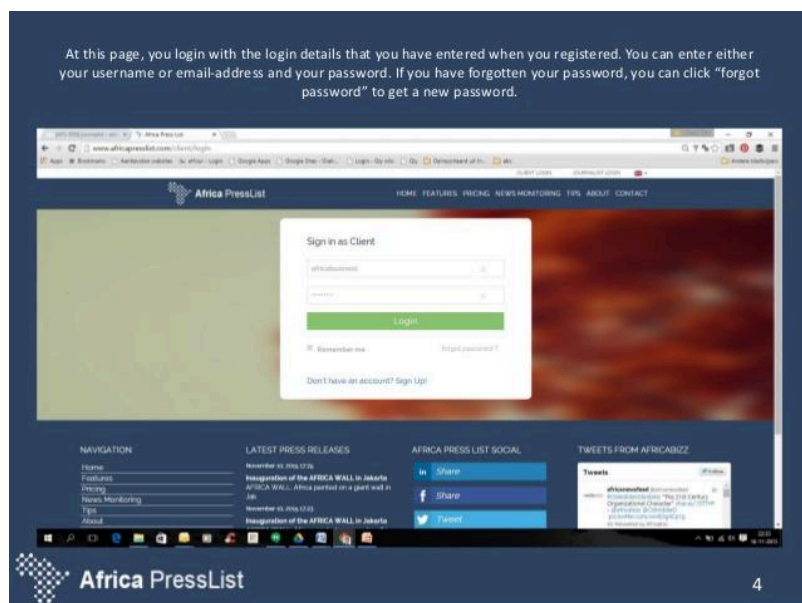
Your articles can get gotten by publishers of online and offline publications and you'll get complete credit. One would think that a business this large just might have seen something amiss, say a day later on.
