You must wait for final approval after submitting your final application and receiving your ITA from Express Entry Canada. Your Acknowledgement of Permanent Residency follows (COPR). After that, you can plan your trip and reserve a flight to Canada.

An immigration representative will let you know when to expect your PR Card. A wallet-sized plastic PR Card will be mailed to you. Therefore, be sure to get it inside the window of time that the immigration officials have set.

When you enter the country, one of the first individuals you'll encounter is a friendly customs agent from Canada. You will take care of your cargo and landing permissions here. Other representatives of [Canada Immigration](#) Services will also be encountered. Your passport and your visa paperwork must be presented.

Your PR card serves as proof that you are a Canadian citizen and permanent resident. You'll need this card each time you return to Canada.

Following your arrival in Canada, there are a few considerations you should make in order to settle quickly. Knowing what to anticipate when you get there will make the process simpler.

Important actions to take as soon as you land in Canada

1. **Locate a place to stay.** It is imperative that you find a place to stay as soon as possible. Once your country of origin has provided you with temporary lodging, it's essential to find a reputable rental home for the foreseeable future. is a great way to easily and quickly begin your search for the appropriate rental. Rentals for Newcomers is a fantastic resource to quickly and easily begin your search for the appropriate rental in Canadian locations.
2. **Obtain a SIN card.** Ask for a Social Insurance Number as soon as you land in Canada (SIN). Without this number, you are unable to apply for a job, credit, or other government assistance. Without it, you are virtually an identity-less person in Canada. One benefit of being a [Canadian permanent resident](#) is being able to obtain your SIN for free.

3. **Obtain a health card** You must apply for a health care card when you arrive in Canada if you want to be eligible for free medical coverage in the province or territory where you intend to reside. As soon as you get there, fill out a health card application. In British Columbia and Ontario, there is a three-month waiting period before you are eligible for public health insurance. So, you should apply for a health care card as soon as you arrive in one of these provinces. In all other provinces and territories, your health insurance coverage commences the moment you arrive.

4. **Look for a suitable job** It's also a great idea to start your job hunt by contacting immigrant settlement organizations. For instance, they can help you:

- Update your resume in preparation for the Canadian employment market.
- Write your cover letter.
- Be prepared for any job interviews.

Many settlement organizations also offer services to assist you in finding employment both before and after you arrive in Canada.

5. **Establish a Bank Account** In the early going, managing your money will be another issue. At a bank or credit union near your home or place of employment, open at least one bank account right away. To open an account, you'll need your landed immigrant documents and any other types of residency proof you may have. Banks provide simple cheque and savings accounts. You might need a cheque account in particular because many employers pay via direct deposit into your account. You can gradually build a solid working connection with your bank and start building your credit history by applying for a secured credit card first and then a standard credit card. When applying for a secured credit card, you must put down cash in case you are unable to make your payments. If you want to have a strong credit history in Canada, it's essential to make your loan and bill payments on time. Your credit history will be useful if you want to get a loan to start a business, a mortgage to rent or buy a property, or both.

6. **Choose settlement assistance services** There are lots of immigrant support organizations all around Canada to help newcomers integrate into society. Settlement groups provide a plethora of free services and advice to help you become used to life in Canada. Even before you arrive in Canada, some settlement organizations can help. Some of the services include:

- Hosts of program
- Settlement advice
- Free language training
