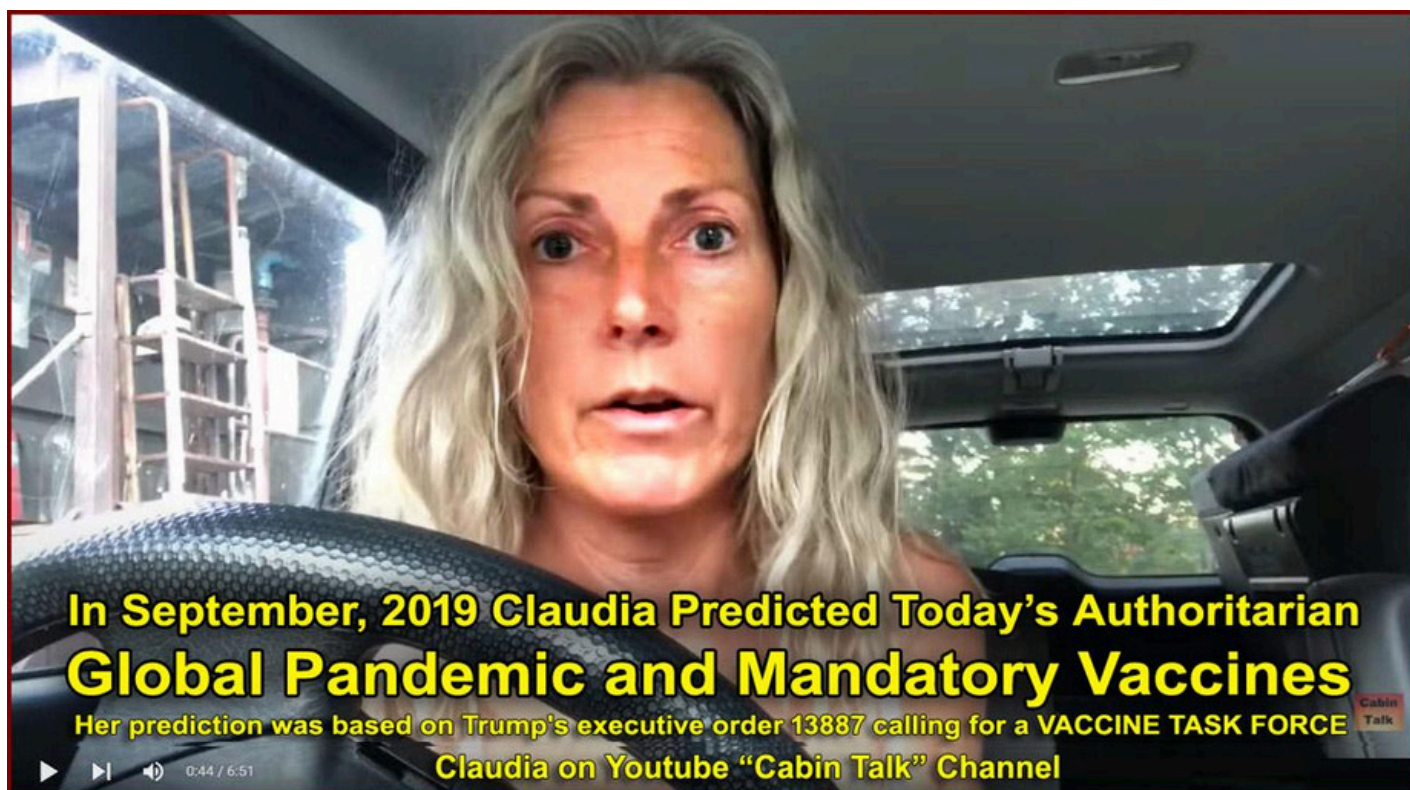

On 9/20/2019, Claudia ([Cabin Talk Youtube channel](#)) posted a video titled, "The next pandemic is just around the corner!", where she emphatically warned that a global pandemic and mandatory vaccines were imminent. **Apparently "YES"**

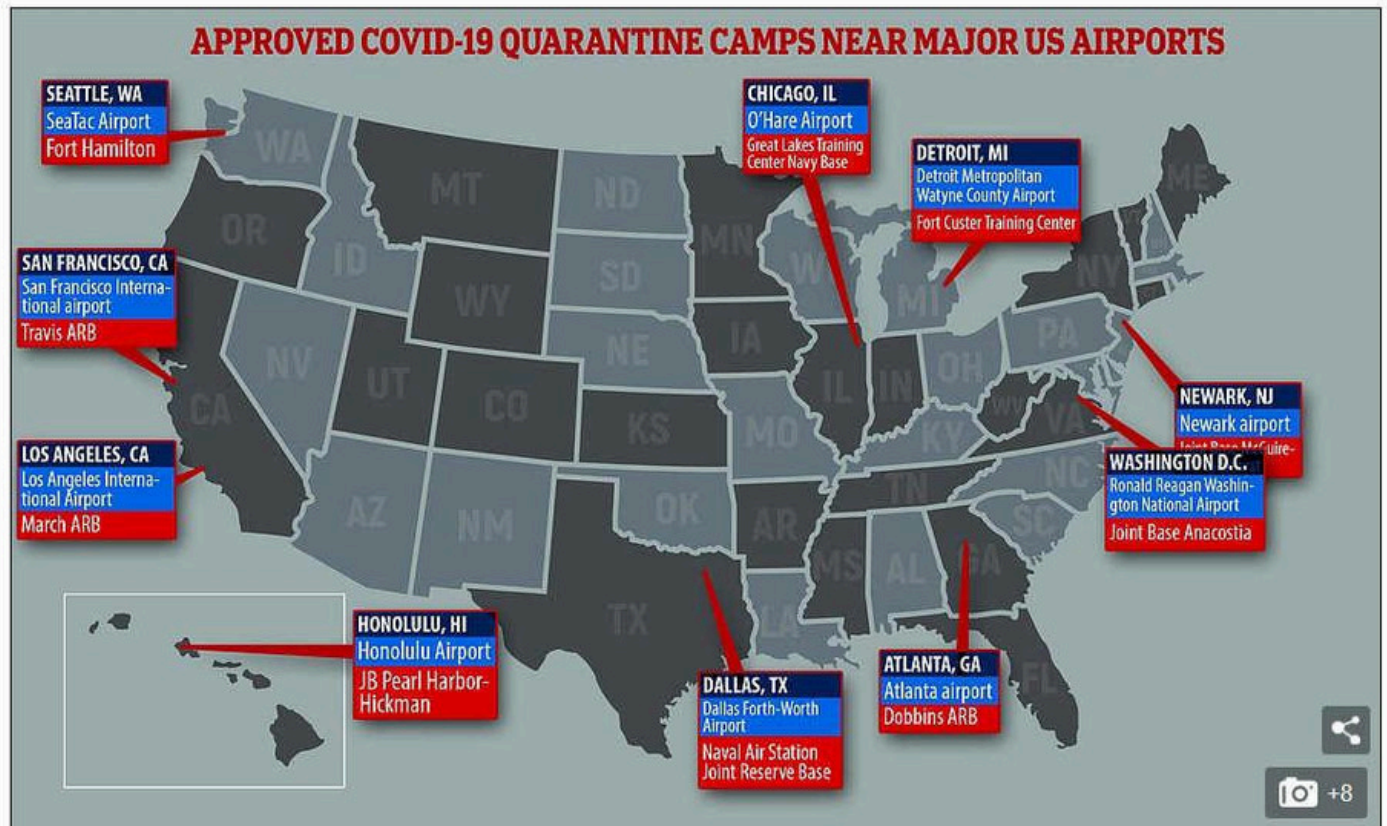

The Coronavirus (Covid-19) outbreak was first identified in Wuhan, Hubei, China in December (31st), 2019 and recognized as a pandemic by the World Health Organization (WHO) on 11 March 2020. [\(WIKI\)](#)

- The 2019–20 coronavirus pandemic is an ongoing pandemic of coronavirus disease 2019 (COVID-19) caused by the severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2).

The outbreak was first identified in Wuhan, Hubei, China on 12/31/2019 but the first death due to the disease did not occur until 1/11/2020. Covid-19 was later recognised as a pandemic by the World Health Organization (W.H.O.) on 3/11/2020 [\(NBCNews\)](#)

A story published by [South China Morning Post](#) reported claims an early Covid-19 case was traced back to 11/17/2019 - however this is dubious since the report was not published on 3/13/2020.
