A sole representative visa is used by an overseas company trying to set up a wholly-owned attachment or a branch of their business for the first time in the UK. This visa is also applicable for any hand from a broadcasting agency or news association overseas assigned to a long-term design in the UK. This visa can be applied online before a period of 3 months from outside the UK. You'll get a decision within 3 weeks outside of the UK and 8

weeks inside of the UK. The visa validity is 3 times and extension can be made up to 2 times. After 5 times, you can apply for a endless agreement inside the UK. However, you can use the services of the SmartMove2UK's visa adviser in Delhi, If you want to apply for a visa from Delhi.

Eligibility for UK Sole Representative Visa

To be eligible for the visa you need to keep in mind the following 2 criteria

- You should have enough plutocrat to support yourself without taking external help or using public finances.
- You must meet the English language demand condition.

The sole representative visa operation will only be valid when

- You're signed by a company whose headquarters are outside the UK.
- You retain the chops to fulfil the job part.
- You hold a elderly position in the company but aren't a maturity shareholder.;
- The branch of the company in the UK must be the first marketable adventure of the company in the UK.

Knowledge of English

When you apply for a sole representative visa, you need to fulfil the criteria of the English language. You can do this using two styles-

By successfully completing an English language test approved by the Home Office up to a position A1 in speaking and harkening.

Having academic qualifications that are original to the UK's bachelorette's degree, master's degree, or Ph.D. tutored in the English language.

There are a many countries mentioned in the visa guidance which are exempted from the English language demand condition by the Home Office. If you hold citizenship of any of those countries also you can be exempted from the English language demand clause. Still, India doesn't come under that list.

Documents you need to give

When you [apply for a sole representative visa](#), you'll need the following documents

- Any form of trip identification like your current passport.
- Necessary substantiation to show that you can support yourself and any dependants during your trip to the UK, like bank statements or payslips of the last 6 months.
- A evidence that you meet the English language demand.

As a sole representative, you must have the following attestations at your disposal

- A complete description of the conditioning of the business, details of means and accounts.
- A written document attesting that your business will set up a branch in the UK with the same business exertion as it has in the overseas parent company.
- Your employment details, job description, and payment details.

You also need substantiation of

- Your direct employment to the business. You mustn't be a deals agent or anything analogous for the company.
- Your reclamation outside of the UK.
- Your position in the company while not being the maturity shareholder.
- Your work in the UK as a full- time part.

For journals, news, and broadcast agencies, the substantiation must include

- A description of the conditioning of the parent company along with means and accounts.
- A evidence of your representation in a full- time part for the company.

You can apply for the visa online and give biometrics in the visa operation center. To help you with the visa operation process, representative UK advisers in Delhi have the experience and knowledge at their disposal to suds through legal issues and make a successful operation for you.

How to extend UK Sole Representative Visa

To extend your visa, you must fulfil the same eligibility criteria that you did when you first applied for the visa. Your visa can be extended for 2 further times after the completion of the 3-time visa period. You need to apply for the extension online and give your biometrics and supporting documents at the visa operation center. The extension period is the same as the operation, that is, 3 weeks.

Who can be a dependant family members?

Any family member is defined as a dependant if the family member is

- A hubby, woman, or mate.
- A child, under the age of 18.

In case a child is born during the period of your stay in the UK, you can apply for a UK dependant visa after furnishing the full UK birth instrument at the visa operation center.
