What is a Patent?

A patent can be defined as the invention right that is granted to an inventor for a limited duration by USPTO (The United States Patent and Trademark Office). Once the inventor has obtained the patent, the details of his/her invention are made public but no one can use it, sell it, or copy it for their benefit. You might face a lot of difficulties while getting the patent but once you have it you can enjoy a monopoly over its use for 20 years from the date of your patent application.
