When you write a cause and effect essay, you need to think of what caused something to happen in order to effectively examine your subject. When formulating conclusions, consider how each piece of evidence may affect your thesis statement. It is also critical to remind yourself that no one size fits all; as everyone has their own personal opinions on every subject imaginable.

The following steps will help outline how you can write a high quality cause and effect essay:

Formulate a thesis statement

- Identify the core cause or causes that led to your event happening. Remember, in any
  argument, there is usually more than one side to the story and you want to give both
  sides equal weight. As such make sure you have evidence supporting both sides of the
  coin
- Your essay must also be written from a neutral position; as this gives an unbiased look
  into what truly caused a situation or event. This will ultimately help readers decide which
  viewpoints are worth taking in consideration about the subject matter at hand
- Once you identify key issues and potential solutions; it is critical to provide concrete proof
  that supports your assertion that this was indeed the cause of your topic being
  discussed. Evidence take the form of facts and statistics which are presented as a way to
  reinforce your argument.

The outline is the first step in writing an effective cause and effect essay. Once you have done that, it is critical to develop a plan for how the body of your essay will look like. When developing this plan, you must keep in mind the two major categories most essays fall into: descriptive/narrative; or analytical/argumentative. These categories focus on what type of information you want to deliver with your piece; along with who your audience is going to be (and why they should care). Depending on the category, choosing a topic will also be different. The following steps will help guide you through writing an effective cause and effect essay:

To do this right, make sure your thesis answers the following questions: "What is the most important claim I want to argue?" and then, "Why should readers believe it?"

• Once you have established your thesis statement, it is time to lay out the specifics of how you are going to write a persuasive piece. Remember, when writing a cause and effect essay; this does not mean that someone else is at fault or that you are trying to redirect blame elsewhere. The purpose of an argumentative essay is more for educating others about why something happened and what can be done so in the future they will be prevented from happening again. You must remember that all events come with unforeseen consequences which may manifest themselves as opportunities. These events could be personal failures or professional setbacks; or they might be an opportunity to help others learn from previous mistakes. While writing an argumentative/cause and effect essay, you must also ensure that each criticism you make is accompanied by a specific solution in order to provide the most compelling piece of work possible.
