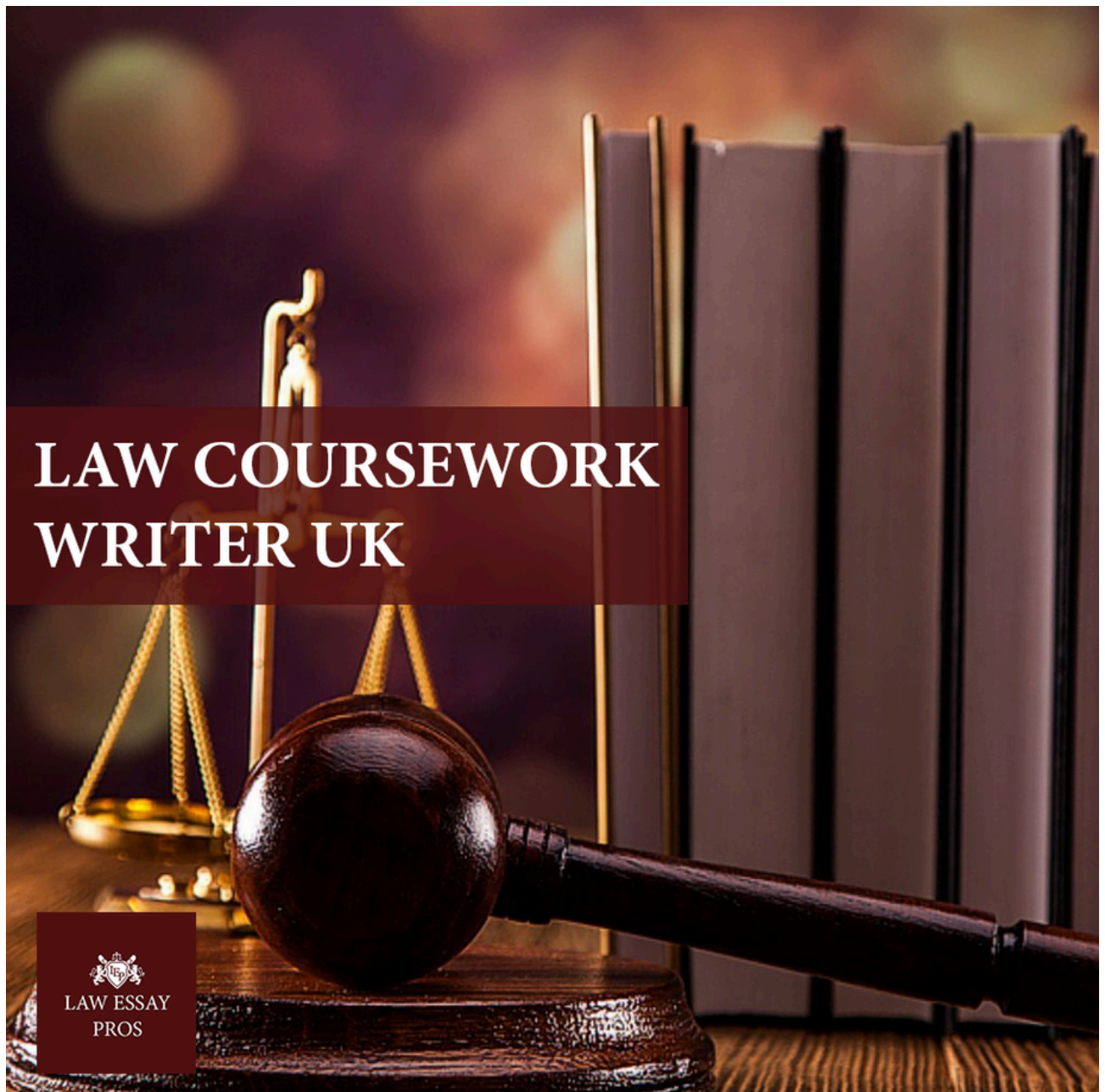




Law Coursework Importance:
