The goal of any international document attestation process is to solve a practical problem, such as allowing civil and judicial officials to verify the legitimacy of a document issued overseas in a reliable manner. It resolves the problem by establishing a chain of attestations from a relatively higher government authority for each document. A foreign jurisdiction can authenticate the entire chain of attestations by validating the signature and seal of this final authority.

Before leaving the country, students pursuing higher education in another country must have their educational documents legalized. Your certifications and resume are not the only documents you'll require. All educational certificates, such as diplomas and degrees, as well as personal documents, such as birth certificates, financial records, and so on, must be attestation from the nation of origin to the country to which you are traveling.
