



MGA Suspends Field of Fortune for Not Paying Charges

Field of Fortune Neglected to Pay Its Expenses

The Approved Individual has neglected to pay sooner rather than later all sums because of the Power.

MGA's Gaming Consistence and Requirement Guidelines

Be that as it may, Field of Fortune neglected to settle up, as indicated by the MGA. The Authority has, consequently, made the suitable move, which is to suspend the administrator's permit. The suspension was antedated to June 28, 2022, onwards.

This implies that Field of Fortune can presently not offer its items in that frame of mind by the MGA. Also, the organization will be expected to promptly settle all exceptional charges owed to the Power.
