



Chances of Spouse visa refusal UK and awaiting a response from the UK Home Office

The waiting period and concern about a [potential visa refusal](#) may be the most challenging aspects of the application procedure for a [UK Spouse visa](#).

However, because applying for a spouse visa is so important, our UK spouse/unmarried and partner visa experts at The SmartMove2UK advise taking these costs into account PRIOR to beginning the application process without legal assistance.

According to the most recent figures from the Home Office, 1 in 4 application for spouse visas are turned down. Applications for a UK Spouse visa are still turned down, even if there is a 1 in 4 probability that they will be.

Due to this plus the 12- to 14-week [processing time for the UK Spouse visa](#), receiving a denial might be disheartening. It would still take 9 to 12 months for a decision even if you wanted to appeal the rejection of your UK visa. Applications are denied for a variety of reasons depending on the application, but there are a few elements that can enhance your spouse's visa for the UK's likelihood of being rejected.

Our team has gathered data for the three years from 2020 to 2022 in order to compare the number of UK Spouse visas approved and denied throughout those three years.

From 2020 to 2022, 4,251 UK Spouse visa requests were rejected, as opposed to 5,087 that were approved.

42,182 UK Spouse visa requests were granted in 2021, compared to 6,682 denials.

In 2022, 16,850 UK spouse visa requests were approved vs 2,339 rejections.

Denials may occur for a variety of reasons, such as failing to provide adequate [evidence of a genuine and subsisting relationship](#), lacking sufficient funds, or failing to demonstrate [sufficient English language proficiency](#).

Lack of knowledge of the requirements or a misreading of the numerous Home Office guidelines could be to blame for the inability to generate the documents.

Steer clear of statistics.
