

#### Dear MISS JANICE LEVER,

We have noted as of this day the 26 February 2023 that there has been no formal legal response to our previous correspondence and we attach again under this same cover the Affidavit and the correspondence sent to you on 22 January 2023, 29 January 2023, 05 February 2023, 12 February 2023 and 19 February 2023 respectively. We therefore note that there is a formal agreement to the following:

## Security and Surety by way of: Lien HOH—JANICE LEVER OFFICER JIGSAW PSHE OFFICER—HOHO160 Affidavit of Truth and Statement of Fact

- 1. I, Baroness Yvonne of the House of Hobbs (being the undersigned), do solemnly swear, declare, and depose:
- 2. That I am competent to state the matters herein and that I do take oath and swear that the matters herein are accurate, correct, honest, and true as contained within this Affidavit of Truth and Statement of Fact.
- 3. That I am herein stating the truth, the whole truth, and nothing but the truth, and that these truths stand as fact until another can provide the material, physical, and tangible evidence and substance to the contrary.
- 4. That I fully and completely comprehend that before any charges can be brought, it must be first proved, by presenting the material, physical, and tangible evidence and substance to support the facts, that the charges are valid and have substance that can be shown to have a foundation in fact.
- 5. That I have first-hand knowledge of the facts stated herein.
- 6. That all the facts stated herein are accurate, correct, honest, and true, and are admissible as material evidence, and that if I am called upon as a witness, that I will testify to their veracity.
- 7. That the eternal, unchanged principals of truth are as follows:
  - a) All are equal and are free by natural descent.
  - b) Truth is factual and not subjective to belief, which is nothing of any material, physical, or tangible substance in fact.
  - c) An un-rebutted Affidavit stands as the truth and fact.
  - d) An un-rebutted Affidavit is the documented fact and truth on and for the record.
  - e) All matters must be expressed to be resolved.
  - f) He who does not rebut the Affidavit agrees to it by default.
  - g) He who does anything by another's hand is culpable for the actions of the other's hand.
  - h) A security by way of a lien is, first and foremost, an agreement between the parties, as there is no disagreement between the parties.
  - i) That he who stands as surety, by providing the security by way of a lien, stands in honour, as that surety is undertaken by agreement, without coercion, duress, or protest, and without the threat of harm, loss, or injury, and, as such, stands in honour for the harm, loss, or injury by their own hand.
- 8. That a security by way of a lien, which is a commercial process (including this Affidavit), is non-judicial and pre judicial, and:
- a. That no judge, court, government, or any agencies thereof, or any third parties whatsoever, can abrogate
  the Affidavit of Truth and Statement of Fact of another, and;



It is now on and for the record and in perpetuity that MISS JANICE LEVER (CLAIMANT) in the position of OFFICER for Jigsaw Education Group Limited Company/State t/a JIGSAW PSHE LTD has never, at any time provided valid, presentable material evidence to support a claim of obligations encumbent upon MRS YVONNE HOBBS or any other to Private Corporations/States by way of a failure of service under a contractual obligation or agreement.
- 16. It is now on and for the record and in perpetuity that MISS JANICE LEVER (CLAIMANT) in the position of OFFICER for Jigsaw Education Group Limited Company/State t/a JIGSAW PSHE LTD has never, at any time provided valid, presentable material evidence to support an omission of the claim you have authority over property corporeal and property real--contra the Terrorism Act--Excommunication by an Officer of a Private Corporation/State to force Us to contract to Our detriment under UK 2011 Education Act and UK 2010 Equality Act.
- 17. It is now on and for the record and in perpetuity that MISS JANICE LEVER (CLAIMANT) in the position of OFFICER for Jigsaw Education Group Limited Company/State t/a JIGSAW PSHE LTD has never, at any time provided valid, presentable material evidence to support the claim there is authority for MISS JANICE LEVER in the position of OFFICER for Jigsaw Education Group Limited Company/State t/a JIGSAW PSHE LTD to wilfuly and premeditatedly Act to cause alarm and distress which is a formally recognised act of terrorism which is also a recognised criminal offence upon MRS YVONNE HOBBS without the presentment of the wet ink signed consent of the 64.1 upon this land and including the wet ink signature of MRS YVONNE HOBBS.
- 18. It is now on and for the record and in perpetuity that MISS JANICE LEVER (CLAIMANT) in the position of OFFICER for Jigsaw Education Group Limited Company/State t/a JIGSAW PSHE LTD has chosen to enter into a lasting and binding tacit agreement through acquiescence by not negating the facts presented in Exhibit (A), and MISS JANICE LEVER (CLAIMANT) in the position of OFFICER for Jigsaw Education Group Limited Company/State t/a JIGSAW PSHE LTD has agreed to the criminal offences documented on and for the record in this correspondence, thus establishing a formal agreement between the parties MISS JANICE LEVER (CLAIMANT) in the position of OFFICER for Jigsaw Education Group Limited Company/State t/a JIGSAW PSHE LTD and MRS YVONNE HOBBS on and for the public record. Since there is no disagreement between the parties, this is a non-judicial matter by default.
- 19. It is now on and for the record and in perpetuity that all matters must be expressed to be resolved and MISS JANICE LEVER (CLAIMANT) in the position of OFFICER for Jigsaw Education Group Limited Company/State t/a JIGSAW PSHE LTD was offered an opportunity to resolve (see Exhibit (B) as material, physical, and tangible evidence and substance and a foundation to this fact). Since it is MRS YVONNE HOBBS who is the victim of these agreed criminal offences of MISS JANICE LEVER (CLAIMANT) in the position of OFFICER for Jigsaw Education Group Limited Company/State t/a JIGSAW PSHE LTD, then MRS YVONNE HOBBS has the right to redress and choose the remedy for these agreed criminal offences.
- 20. It can be noted here, for and on the record, that the remedy for the criminal offence of fraud is seven to ten years' incarceration, the latter where there are multiple instances of fraud. MRS YVONNE HOBBS is under no legal or statutory obligation to observe and act upon the State policy regarding this matter and would consider that this extensive term of incarceration would be an insurmountable encumbrance on





the public purse. For these reasons, it is MRS YVONNE HOBBS to offer alternative

- 21. A second option was also proposed, which is

It is important to note here on and for the record that MISS JANICE LEVER (CLAIMANT) in the position of OFFICER for Jigsaw Education Group Limited Company/State t/a JIGSAW PSHE LTD has chosen by their actions not to resolve his debt by way of personal cheque or a commercial instrument. It is also important to state here on and for the record that MISS JANICE LEVER (CLAIMANT) in the position of OFFICER for Jigsaw Education Group Limited Company/State t/a JIGSAW PSHE LTD has not communicated by any means reluctance or objection to stand as surety and provide security by way of a lien on the estate and future earnings of MISS JANICE LEVER (CLAIMANT) in the position of OFFICER for Jigsaw Education Group Limited Company/State t/a JIGSAW PSHE LTD extended to the future generations of MISS JANICE LEVER (CLAIMANT) in the position of OFFICER for Jigsaw Education Group Limited Company/State t/a JIGSAW PSHE LTD where the sins of the father are the sins of the sons to the seventh generation, and where there may be an attachment of earnings on future generations of MISS JANICE LEVER.
- 23. MISS JANICE LEVER (CLAIMANT) in the position of OFFICER for Jigsaw Education Group Limited Company/State t/a JIGSAW PSHE LTD has not disagreed by any means of communication or correspondence to stand as surety for a security by way of a lien for his criminal offences, which have been fully documented and declared by way of this affidavit. As a consequence of not disagreeing with this proposed remedy, MISS JANICE LEVER (CLAIMANT) in the position of OFFICER for Jigsaw Education Group Limited Company/State t/a JIGSAW PSHE LTD has formally agreed to this remedy to stand as surety, and agrees to be a security by way of a lien, and once again stands in honour by their actions by accepting the proposed remedy in full knowledge and understanding, without coercion or deception, and without the threat of harm, loss, or injury.

- 24. In accordance with the traditions of this land and as this is a lien then this will be published in all the necessary places.
- 25. Ignorance is no defence for committing criminal acts. Considering the position of OFFICER for Jigsaw Education Group Limited Company/State t/a JIGSAW PSHE LTD, MISS JANICE LEVER in the position of OFFICER for Jigsaw Education Group Limited Company/State t/a JIGSAW PSHE LTD should have shown more diligence and accountability in the office. It is our considered opinion, due to the severity of the most grievous agreed criminal offences, that MISS JANICE LEVER in the position of OFFICER for Jigsaw Education Group Limited Company/State t/a JIGSAW PSHE LTD is no longer a fit and proper person to hold any trusted position in service in the office.
- 26. It can also be considered that since these most grievous agreed criminal offences have been committed in the office of Jigsaw Education Group Limited Company/State t/a JIGSAW PSHE LTD which is detrimental to the function and the interests of Jigsaw Education Group Limited Company/State t/a JIGSAW PSHE LTD and that MISS JANICE LEVER in the position of OFFICER for Jigsaw Education Group Limited Company/State t/a JIGSAW PSHE LTD has acted in an ultra vires capacity in the position as OFFICER for Jigsaw Education Group Limited Company/State t/a JIGSAW PSHE LTD and without the legal authority to do so, thus it can be concluded that MISS JANICE LEVER (Claimant) in the position of OFFICER for Jigsaw Education Group Limited Company/State t/a JIGSAW PSHE LTD could be held culpable for their actions as not in the best interests of Jigsaw Education Group Limited Company/State t/a JIGSAW PSHE LTD.
- 27. Let it be known on and for the record that MISS JANICE LEVER (Claimant) In the position of OFFICER for Jigsaw Education Group Limited Company/State t/a JIGSAW PSHE LTD has chosen, of their own free will, to stand as surety for a security by the way of a lien to the amount of A Hundred and Thirty Five million pounds GBP (£135,000,000.00 GBP). From Exhibit (C) of this Affidavit, in the House of Ward Affidavit of Truth and Statement of Fact, which is on and for the record, it is noted that the legal tender or fiscal currency, which ever term is used, is representative of confidence, faith, and belief, so this surety for a security by way of a lien is equal to A Hundred and Thirty Five million pounds GBP (135,000,000.00 GBP) of confidence, faith, and belief.
- 28. Let it be known on and for the record that confidence, faith, and belief are nothing of any material, physical, or tangible substance or evidence in fact.
- 29. Let it be known on and for the record that since MISS JANICE LEVER (Claimant) in the position of OFFICER for Jigsaw Education Group Limited Company/State t/a JIGSAW PSHE LTD has agreed to this remedy of their own free will, in full knowledge and understanding, without coercion or deception, and without threat of harm, loss, or injury, that MISS JANICE LEVER (Claimant) in the position of OFFICER for Jigsaw Education Group Limited Company/State t/a JIGSAW PSHE LTD stands in honour, and their dignity is restored by their own hand in the community regarding this matter.



# Jigsaw, the mindful approach to PSHE, ages 3-11 How does Jigsaw approach gender identity?

This document has been written to outline Jigsaw's philosophy to value all children, and how this is reflected in its approach to gender identity, the use of language referring to boys, girls, males, females etc and our aim to provide a balanced and inclusive approach.

At Jigsaw we, of course, understand the difference between 'sex' and 'gender' and adopt the World Health Organisation distinction.

'The World Health Organisation regional office for Europe describes sex as characteristics that are biologically defined, whereas gender is based on socially constructed features. They recognise that there are variations in how people experience gender based upon self-perception and expression, and how they behave'

Jigsaw's underpinning philosophy is to value every child as the unique human beings they are, and from this premise promotes acceptance and respect for self and others.

The relationship children have with themselves is paramount and Jigsaw focuses on developing a strong sense of identity, self-belief and self-esteem, within the whole-school PSHE programme. Jigsaw also includes all the requirements of statutory Relationships and Health Education (DfE England 2019).

The first Puzzle (unit) in Jigsaw is 'Being Me in My World' which is about discovering who I am and how I fit... in my family, my school, my friendship groups and as a global citizen.

The second Puzzle is 'Celebrating Difference' which is about identifying similarities and celebrating difference, returning to the underpinning aim of acceptance and respect for each person's uniqueness. This Puzzle also considers how sometimes difference can be a source of bullying, racism etc, children always being taught how to speak up and get help if needed.

Jigsaw works hard on ensuring age-appropriateness throughout, and we strongly encourage teachers to plan every lesson and tailor it if necessary, to ensure it meets the needs of their pupils.

The issue of gender identity is rarely treated as an explicit focus in Jigsaw 3-11 as the programme does its best to create an inclusive ethos as described above. There are opportunities for transgender to be included in classroom discussions at the teacher's discretion, but there is only one lesson (for children aged 10-11 years) where this term is used explicitly.


At no point does Jigsaw say there are only two genders but equally it doesn't suggest there are more; neither, in the primary programme does it refer to gender fluidity.



Jigsaw is very aware of the challenge of a binary-focused English language and does its best to use a mix of boy/girl language and gender-neutral language e.g. for names of characters in stories and scenarios etc. Jigsaw tries to reflect the diverse demographic children are a part of, always emphasising the importance of being kind, compassionate and accepting, focussing on the qualities of people as human beings, accepting children who see themselves as boys, as girls, as non-binary etc.

The Jigsaw Friends have gender- and culture-neutral names e.g. Jigsaw Jo, Jino, Jaz.

The language of 'boy' and 'girl' is used with careful attention not to stereotype.



There are explicit lessons that help children understand what stereotyping is, why it can be damaging and how to avoid doing this, always encouraging children to be who they are and celebrate their own identity and to treat others in the same way.

This means our Jigsaw approach is one we feel will fit most schools and most children, valuing children from all types of families, including those with family members who do not fit typical gender stereotypes, and those children who may struggle with their own sense of how they fit in.

When schools are aware of children who are questioning their gender, or have family members who are transgender, we know that schools want to ensure that they can acknowledge these children's experiences positively in the classroom as they do for all children in all sorts of different family compositions.

Sometimes there are children or family members who may be transgender or questioning their gender, that the school will not know about. We also know that as primary children get older, they will become increasingly aware of people and stories in the media about transgender people.

Consequently, it is important that there is some specific content built into Jigsaw that recognises transgender people as equally important members of the community and allows safe and age-appropriate discussion around the concept of transgender for primary aged children if and when it is appropriate for a class, at the teacher's discretion.

We would expect children to then feel more comfortable to take any further questions they may have home to their own families.

There are more than 250 lessons in the primary Jigsaw Programme. There is one lesson in KS1 and one in KS2 where transgender identities could be said to be explicitly reflected, although the term 'transgender' is only explicitly introduced in the materials in one lesson in Year 6 (Age 10-11 materials).




So, what is in these lessons?

Age 6-7 years, Celebrating Difference, Lesson 5, 'Gender Diversity'.

This lesson looks at whether being a boy or a girl makes a difference when choosing friends and toys. The lesson includes a character who the children do not know is a girl or a boy to help stimulate discussion about whether this makes a difference. There is no reference to LGBT+, but if a school does have a child who is questioning their gender identity, or a family member who is transgender, it may help to reflect that child's experience of the world and provide a safe classroom environment for the children to discuss any issues they have questions about. The safe learning environment is reinforced each lesson by the Jigsaw Charter established with children's ownership in the very first Jigsaw lesson.

The following 5 slides are **an excerpt** from this lesson which focuses on being kind to each other and being individuals. The main aim of the lesson is about treating everyone as individuals and that it is fine to be who you are, to have your own identity. Teachers use their discretion, knowing the children in their classes, and are encouraged to focus the lesson accordingly.













#### Age 10-11 years, Celebrating Difference, Lesson 2 'Understanding Difference'

This lesson for pupils aged 10-11 on the Equality Act, provides a safe learning environment for children to consider age-appropriately what transgender means. We know that most schools have had questions raised by the end of primary about what transgender means, and in Jigsaw it is introduced in this wider lesson on equality and the law.

The story of Robert/Roberta Cowell is deliberately chosen as this historic figure is removed from the fashion and media hype that influences so much current discussion around transgender. This means that it allows for a more age-appropriate discussion of the difficulties that someone who does not fit into society's stereotypes might feel, and why it is important for people to be protected by law. Its emphasis is on Roberta as a human being and her achievements as well as people's attitudes towards her at the time.

The learning activity in the lesson following the teacher input then broadens out to focus on some of the other protected characteristics in the Equality Act.

Jigsaw provides teacher notes to give ideas of how adults in the classroom could respond to questions on transgender, encouraging teachers to remember that the lesson is focussing on the importance on understanding how important it is to treat people as individuals and that for some this right is written in law, rather than focussing the lesson on the detail of what the term 'transgender' means. Schools can look at these notes and check they fit with their agreed approach to this issue in relation to the needs of the children in the class and the school community.

At no point does Jigsaw relay a 'wrong-body' narrative. Equally at no point does Jigsaw go into detail in terms of transitioning.

Jigsaw pays careful attention to the images it uses in its materials and is mindful of reflecting diversity and not promoting stereotypes, so all children can resonate with what they see.

Distancing techniques are also used in Jigsaw e.g. cartoon characters from the Planet Zarg, enabling learning messages to be free from the risk of stereotyping. This is a consistent approach from age 3 years upwards allowing all children to see themselves and their families and friends represented in our classroom resources and discussions, whatever our differences in our appearance, outlook or of course, gender identity.

Understanding puberty and human reproduction, at primary school, of course needs knowledge of both the male and female body. Jigsaw uses the words: male,



female, boy, girl in such lessons and suggests teachers use terminology like 'birth-body' if they deem this is appropriate.

Jigsaw is all about preparing children for the world they live in and supporting them to be happy in their own identity and respectful of others.



In addition to this an act of force where there is no material evidence and substance to a valid claim is also an act of *in terrorem*, a wilful and belligerent act of terrorism.



We would point your attention to Exhibit (D) of the Affidavit and Statement of Fact for Case Authority WI-05257F. 30d of May 2013 that a corporation must execute documents legally and failure to do so renders the documents non legal and void—(1) Under the law of England and Wales or Northern Ireland a





document is executed by a company—(a) by its common seal, or (b) by signature in document is validly executed by a company

the affixing of accordance with the following provisions. (2) A if it is signed on behalf of the company— (a) by

two authorised signatories, or (b) by a director of the company in the presence of a witness who attests the signature. (4) A document signed in accordance with subsection (2) and expressed in whatever words, to be executed by the company, has the same effect as if executed under the common seal of the company. The legal effect of the statute is that documents and deeds must be signed on behalf of the company by a director in the presence of a witness, or by two authorised signatories. Without adherence to these provisions no contracts can be considered duly executed by a company and their terms are therefore legally unenforceable.

We also draw attention to the UK 2006 Fraud Act, Part 35, section 3--Fraud by failing to disclose information A person is in breach of this section if he—(a) dishonestly fails to disclose to another person information which he is under a legal duty to disclose, and (b) intends, by failing to disclose the information—(i)to make a gain for himself or another, or (ii)to cause loss to another or to expose another to a risk of loss.

We now refer you to Exhibit (A) of the Affidavit which defines that profiteering contravenes the UK 2006 Fraud Act. We should also point out to you that it is a direct contravention of the UK 2000 Terrorism Act, s.15 Fund raising is an offence if a person invites another to provide money or other property and intends that it should be used for the purposes of terrorism. There are further requirements under the UK 2006 Fraud Act, Part 35, section 2--FRAUD by ABUSE of POSITION (1)A person is in breach of this section if he—(a) occupies a position in which he is expected to safeguard, or not to act against, the financial interests of another person, (b) dishonestly abuses that position, and (c) intends, by means of the abuse of that position—(i) to make a gain for himself or another, or (ii) to cause loss to another or to expose another to a risk of loss. (2) A person may be regarded as having abused his position even though his conduct consisted of an omission rather than an act.







# Jigsaw, the mindful approach to PSHE, ages 3-11 How does Jigsaw approach gender identity?

This document has been written to outline Jigsaw's philosophy to value all children, and how this is reflected in its approach to gender identity, the use of language referring to boys, girls, males, females etc and our aim to provide a balanced and inclusive approach.

At Jigsaw we, of course, understand the difference between 'sex' and 'gender' and adopt the World Health Organisation distinction.

'The World Health Organisation regional office for Europe describes sex as characteristics that are biologically defined, whereas gender is based on socially constructed features. They recognise that there are variations in how people experience gender based upon self-perception and expression, and how they behave'

Jigsaw's underpinning philosophy is to value every child as the unique human beings they are, and from this premise promotes acceptance and respect for self and others.

The relationship children have with themselves is paramount and Jigsaw focuses on developing a strong sense of identity, self-belief and self-esteem, within the whole-school PSHE programme. Jigsaw also includes all the requirements of statutory Relationships and Health Education (DfE England 2019).

The first Puzzle (unit) in Jigsaw is 'Being Me in My World' which is about discovering who I am and how I fit... in my family, my school, my friendship groups and as a global citizen.

The second Puzzle is 'Celebrating Difference' which is about identifying similarities and celebrating difference, returning to the underpinning aim of acceptance and respect for each person's uniqueness. This Puzzle also considers how sometimes difference can be a source of bullying, racism etc, children always being taught how to speak up and get help if needed.

Jigsaw works hard on ensuring age-appropriateness throughout, and we strongly encourage teachers to plan every lesson and tailor it if necessary, to ensure it meets the needs of their pupils.

The issue of gender identity is rarely treated as an explicit focus in Jigsaw 3-11 as the programme does its best to create an inclusive ethos as described above. There are opportunities for transgender to be included in classroom discussions at the teacher's discretion, but there is only one lesson (for children aged 10-11 years) where this term is used explicitly.


At no point does Jigsaw say there are only two genders but equally it doesn't suggest there are more; neither, in the primary programme does it refer to gender fluidity.



Jigsaw is very aware of the challenge of a binary-focused English language and does its best to use a mix of boy/girl language and gender-neutral language e.g. for names of characters in stories and scenarios etc. Jigsaw tries to reflect the diverse demographic children are a part of, always emphasising the importance of being kind, compassionate and accepting, focussing on the qualities of people as human beings, accepting children who see themselves as boys, as girls, as non-binary etc.

The Jigsaw Friends have gender- and culture-neutral names e.g. Jigsaw Jo, Jino, Jaz.

The language of 'boy' and 'girl' is used with careful attention not to stereotype.



There are explicit lessons that help children understand what stereotyping is, why it can be damaging and how to avoid doing this, always encouraging children to be who they are and celebrate their own identity and to treat others in the same way.

This means our Jigsaw approach is one we feel will fit most schools and most children, valuing children from all types of families, including those with family members who do not fit typical gender stereotypes, and those children who may struggle with their own sense of how they fit in.

When schools are aware of children who are questioning their gender, or have family members who are transgender, we know that schools want to ensure that they can acknowledge these children's experiences positively in the classroom as they do for all children in all sorts of different family compositions.

Sometimes there are children or family members who may be transgender or questioning their gender, that the school will not know about. We also know that as primary children get older, they will become increasingly aware of people and stories in the media about transgender people.

Consequently, it is important that there is some specific content built into Jigsaw that recognises transgender people as equally important members of the community and allows safe and age-appropriate discussion around the concept of transgender for primary aged children if and when it is appropriate for a class, at the teacher's discretion.

We would expect children to then feel more comfortable to take any further questions they may have home to their own families.

There are more than 250 lessons in the primary Jigsaw Programme. There is one lesson in KS1 and one in KS2 where transgender identities could be said to be explicitly reflected, although the term 'transgender' is only explicitly introduced in the materials in one lesson in Year 6 (Age 10-11 materials).




So, what is in these lessons?

Age 6-7 years, Celebrating Difference, Lesson 5, 'Gender Diversity'.

This lesson looks at whether being a boy or a girl makes a difference when choosing friends and toys. The lesson includes a character who the children do not know is a girl or a boy to help stimulate discussion about whether this makes a difference. There is no reference to LGBT+, but if a school does have a child who is questioning their gender identity, or a family member who is transgender, it may help to reflect that child's experience of the world and provide a safe classroom environment for the children to discuss any issues they have questions about. The safe learning environment is reinforced each lesson by the Jigsaw Charter established with children's ownership in the very first Jigsaw lesson.

The following 5 slides are **an excerpt** from this lesson which focuses on being kind to each other and being individuals. The main aim of the lesson is about treating everyone as individuals and that it is fine to be who you are, to have your own identity. Teachers use their discretion, knowing the children in their classes, and are encouraged to focus the lesson accordingly.













#### Age 10-11 years, Celebrating Difference, Lesson 2 'Understanding Difference'

This lesson for pupils aged 10-11 on the Equality Act, provides a safe learning environment for children to consider age-appropriately what transgender means. We know that most schools have had questions raised by the end of primary about what transgender means, and in Jigsaw it is introduced in this wider lesson on equality and the law.

The story of Robert/Roberta Cowell is deliberately chosen as this historic figure is removed from the fashion and media hype that influences so much current discussion around transgender. This means that it allows for a more age-appropriate discussion of the difficulties that someone who does not fit into society's stereotypes might feel, and why it is important for people to be protected by law. Its emphasis is on Roberta as a human being and her achievements as well as people's attitudes towards her at the time.

The learning activity in the lesson following the teacher input then broadens out to focus on some of the other protected characteristics in the Equality Act.

Jigsaw provides teacher notes to give ideas of how adults in the classroom could respond to questions on transgender, encouraging teachers to remember that the lesson is focussing on the importance on understanding how important it is to treat people as individuals and that for some this right is written in law, rather than focussing the lesson on the detail of what the term 'transgender' means. Schools can look at these notes and check they fit with their agreed approach to this issue in relation to the needs of the children in the class and the school community.

At no point does Jigsaw relay a 'wrong-body' narrative. Equally at no point does Jigsaw go into detail in terms of transitioning.

Jigsaw pays careful attention to the images it uses in its materials and is mindful of reflecting diversity and not promoting stereotypes, so all children can resonate with what they see.

Distancing techniques are also used in Jigsaw e.g. cartoon characters from the Planet Zarg, enabling learning messages to be free from the risk of stereotyping. This is a consistent approach from age 3 years upwards allowing all children to see themselves and their families and friends represented in our classroom resources and discussions, whatever our differences in our appearance, outlook or of course, gender identity.

Understanding puberty and human reproduction, at primary school, of course needs knowledge of both the male and female body. Jigsaw uses the words: male,



female, boy, girl in such lessons and suggests teachers use terminology like 'birth-body' if they deem this is appropriate.




