State Nomination Allocation for 190 Visa and 491 Visa FY 2024-25

The Australian government has announced the state nomination allocation for 190 Visa and 491 Visa. The current state nomination is applicable for the 2024-25 program year. There are a total of 16,500 state nomination places for 190 Visa and 9,760 state nomination places for 491 Visa.

Below is the breakdown across the Australian states and territories.

State Nomination Allocation in ACT

The total state nomination allocation for the Australian Capital Territory (ACT) is 1,800 places. The allocation is divided into:
