### **Type 21 Liquor License vs. Other Liquor Licenses**

California has various liquor licenses for different business categories. This is how a Type 21 Liquor License stands in relation to other typical licenses:

- Type 20 (Off-Sale Beer & Wine) – Enables beer and wine sales only, excluding spirits.
- Type 41 (On-Sale Beer & Wine – Eating Place) – Enables beer and wine sales in restaurants with the requirement of food service.
- Type 47 (On-Sale General – Eating Place) – Permits restaurants to sell beer, wine, and liquor, but food shall be the main source of profit.
- Type 48 (On-Sale General – Public Premises) – For bars and nightclubs where alcoholic beverages are consumed on the premises with no food service.

For wholesale retailers that intend to sell alcoholic drinks of all kinds, the Type 21 Liquor License should be used.

### **Buy a Liquor License**

If you're interested in purchasing a Type 21 Liquor License, follow these steps:

**Research Availability** – The number of licenses issued is limited, so check if one is available in your area.

**Determine Costs** – Prices vary based on location and demand, with some licenses costing tens of thousands of dollars.

**Confirm Compliance** – Ensure the license is in good standing prior to purchasing.

**Execute the Transfer** – Adhere to ABC procedures for transferring ownership lawfully.
