Type 21 – Off-Sale General: Same as Type 20 but includes spirits, which would be ideal for liquor stores.

Type 41 – On-Sale Beer and Wine: Restaurant license that permits beer and wine sales but includes the requirement that alcohol be served with food.

Type 47 – On-Sale General: Restaurants can sell beer, wine, and spirits, but at least 50% of total revenue must come from food.

Type 48 – On-Sale General (Nightclubs and Bars): This license type is for nightclubs and bars that sell liquor without the need for food service. The customers must be at least 21 years of age.

Knowing these types of licenses will ensure your business is operating within the law and meeting the requirements for the sale of alcohol.

Assuming that there are no objections and that you have met all the prerequisites, the ABC will grant your application. You will have to pay for licensing fees before receiving your Los Angeles liquor license.
