Type 20 License: This off-sale beer and wine license permits establishments like convenience stores and grocery stores to sell beer and wine for off-premises consumption.

This license does not allow the sale of open containers or the consumption of alcohol on-site. Additionally, there are no restrictions preventing minors from being present on the premises

Type 21 License: An off-sale general license that allows retailers to sell beer, wine, and distilled spirits for off-premises consumption, making it popular among liquor stores.

In California, the Type 21 liquor license permits retailers to sell packaged beer, wine, and distilled spirits for off-premises consumption. This license is ideal for businesses such as liquor stores, grocery stores, and convenience stores that wish to offer a comprehensive selection of alcoholic beverages to their customers. Unlike the Type 20 license, which restricts sales to beer and wine, the Type 21 license allows for the sale of all types of alcoholic beverages. However, it does not permit the sale of open containers or on-site consumption. Additionally, there are no restrictions preventing minors from being present on the premises

Type 47 License: An on-sale general eating place license that allows restaurants to serve beer, wine, and distilled spirits on the premises, provided they maintain suitable kitchen

In California, the Type 47 liquor license is essential for restaurant owners who wish to offer a full spectrum of alcoholic beverages, including beer, wine, and distilled spirits, for on-premises consumption. To qualify, establishments must operate as bona fide eating places, maintaining suitable kitchen facilities and generating at least 51% of their gross sales from food. This requirement underscores the primary focus on dining, distinguishing such venues from bars or nightclubs. The comprehensive nature of the Type 47 license often makes it more costly compared to licenses permitting only beer and wine sales

Type 48 License: Intended for bars and nightclubs, this on-sale general public premises license permits the sale of beer, wine, and distilled spirits for on-premises consumption. Unlike the Type 47 license, a Type 48 license does not require the premises to operate as a bona fide eating place, and minors are not allowed to enter or remain on the premises

In California, the Type 48 liquor license is designated for establishments such as bars and nightclubs that exclusively serve patrons aged 21 and over. Unlike the Type 47 license, there is no requirement for food service, allowing these venues to focus solely on alcoholic beverage sales. The application process for a Type 48 license is rigorous, involving strict adherence to city regulations and zoning laws. The cost of obtaining this license can vary significantly based on factors like location and market demand. As of October 2024, the application fee is \$15,835, with annual fees ranging from \$790 to \$1,235.
