

The **2006 New York City plane crash** occurred on October 11, 2006, when a Cirrus SR20 general aviation, fixed-wing, single-engine light aircraft crashed into the Belaire Apartments in New York City at about 2:42 p.m. local time (18:42 UTC). The aircraft struck the north side of the building, located on the Upper East Side of Manhattan, causing a fire in several apartments,^{[2][3]} which was extinguished within two hours.^[4]

Both people aboard the aircraft were killed in the accident: New York Yankees pitcher Cory Lidle^[3] and his certified flight instructor Tyler Stanger.^{[5][6]} Twentyone people were injured, including eleven firefighters. An apartment resident who lived in the building with her husband, Ilana Benhuri, was hospitalized for a month with severe burns incurred when the post-impact fire engulfed her apartment.^{[7][8]}






The fire was put out very quickly and the crash left plenty of wreckage down on the street below. Something we did not see on 9/11.

On 9/11, Flight 93 allegedly disappeared into the dirt.

New York City

This image reminded me of the 'fires' at the Ground Zero site in NYC after the towers were destroyed. The so called 'heat' on 9/11 seemed to effect metal more than paper...

Usually, the absorption of waves does not depend on their intensity (linear absorption), although in certain conditions (usually, in optics), the medium changes its transparency dependently on the intensity of waves going through, and saturable absorption (or nonlinear absorption) occurs.

Concerned about the BP oil gusher disaster, John Hutchison and his research partner, Nancy Lazaryan have come up with a combination of audio and radio frequencies that now have been shown scientifically to reduce the oil and grease in polluted waters in the Gulf of Mexico from 7 ppm to less than 1 ppm, restoring the water's vitality as manifest by the return of fish, dolphins and even barnacles to a region of Perdido Bay in Lillian, Alabama, USA, where they conducted their first test.

"The local residents may now finally have hope for getting their Gulf back and restoring it to the healthy body it once was, if not better, before the Oil Disaster," said Cara Fay, who is a friend of John and Nancy, and has been following their work on this project, which began in July, when a sample of polluted water was sent to John's lab in Vancouver, BC. Based on success in finding the right frequencies, John and Nancy recently headed to the Gulf to try a test on location, with scientific documentation by a chemistry lab to corroborate their observations.

Test Results

The exact reach and potency of the frequencies is yet to be determined, but the device John assembled for this research pulls two kilowatts and, judging subjectively, appears to effect a region of at least more than 1000 yards radially (like a sphere), as verified by sympathetic resonance in the water (detected by oscilloscope) from the projection of audio and radio frequencies over the water. Nancy speculates that the effected area could be as much as several miles. All of the equipment ran off of one extension cord (110 V, 20 amp).

The area was treated with the frequencies for four hours the first day, and by the next morning, the waters were cleared. They then did four more hours of RF frequency that day, to complete the test. The frequency device was situated about 25 feet up the beach from the water.

The test was also documented by chemist Bob Naman, President of Analytical Chemical Testing Laboratory, Inc. (ACT) of Mobile, Alabama. He is a Fellow of the American Institute of Chemists,

Nancy, who is from Minnesota, who has experience as a professional broadcast TV camera person, filmed the restoration of sea life, with clearing of the water, new green algae, dolphins, and fish, the day following their test. She said:

"The fish were jumping, ...the water that had been murky brown was a clear green. Two dolphins came into 5 feet of water to visit. Lots of schools of fish and crabs [were] very active in the 'healed waters'. These tones were used by the ancients to HEAL humans."






Many of these effects also took place at the World Trade Center on September 11th. Not to mention the hurricane parked outside the coast of New York of 9/11.



But it did. Just because someone cannot understand how it happen doesn't make it untrue. It *DID* happen & the govt. even confessed.



COTTAGE IN THE WOODS WAS TURNED INTO 'A TOTAL RUIN'

Another notable piece of evidence is the damage that was suffered by a cottage near the alleged crash site. The *Pittsburgh Post-Gazette* reported that "every window and door" of the cottage "had been blown off and obliterated, [the cottage's] ceilings and floor tiles had been blasted loose, and much of the interior was wrecked." [83] Furniture had been tossed around, the refrigerator was twisted backwards and shoved away from the wall, and items had been thrown from the cupboards onto the floor. [84]

Barry Hoover, the man who lived in the cottage, found a large amount of debris, apparently from Flight 93, surrounding his home, including "papers strewn everywhere ... small pieces of wire all over ... just a lot of small bits of fragmented debris." [85] Now & Then magazine reported that the impact of debris from the plane made the cottage "structurally unsound, shifting it an inch and a half off the foundation." [86]

The garage next to the cottage was also badly damaged, with its door turned "inside out and upside down." Local solicitor Daniel Rullo recalled, "The way it was described to me was that [the garage door] must have been blown up, the springs snapped, and it came back upside down." [87]

What is more, Carol Delasko said the cloud of confetti-like debris she saw over Indian Lake had been "rising about 200 feet into the air" around the time the crash apparently occurred. [81] Had this debris come from an aircraft breaking up in mid-air, it surely would not have been "rising." And Brad Boyer said the material he saw coming down onto the lake included "leaves. A lot of leaves." [82] Surely leaves would not have fallen out of an aircraft disintegrating in the sky.

We also have this DEP report of: "No jet fuel in the soil at Flight 93 crash site.

This evidence rules out airplanes as well as missiles. Since both of them would have left fuel behind.

Some still believe there was a missile in the air.

This is due to the witness accounts of a "small white plane" or what "sounded like" a missile overhead in Shanksville, PA.

Should we really assume that these people were seeing a <u>JASSM missile that looked like a</u> <u>plane</u>? No, we shouldn't. Especially since this particular missile was not functioning in 2001.


In 1999, powered flight tests of the missile began. These were successful, and production of the JASSM began in December 2001. The weapon began operational testing and evaluation in 2002. Late that year, two missiles failed tests and the project was delayed for three months before completing development in April 2003. Two more launches failed, this time as a result of launcher and engine problems. In July 2007, a \$68 million program to improve JASSM reliability and recertly the missile was approved by the Pentagon.^[5] A decision on whether to continue with the program was deferred until Spring 2008.^[6] Lockheed agreed to fix the missiles at its own cost and has tightened up its manufacturing processes.^[7]

On 27 August 2009, David Van Buren, assistant secretary of the Air Force for acquisition, said that there would be a production gap for the JASSM while further tests were held.^[8] Further tests in 2009 were more successful however, with 15 out of 16 rounds hitting the intended target, well above the 75% benchmark set for the test. As such JASSM is now cleared for service entry.^[9] The United States Air Force plans to acquire up to 4,900 AGM-158 missiles.^[10] Meanwhile, the United States Navy had originally planned to acquire 453^[11] AGM-158 missiles but pulled out of the program in favor of employing the proven SLAM-ER.^[10]

Isn't it just as possible this "small white plane" that was spotted in Shanksville, was indeed a small white plane?

Especially since the same thing was seen that day at the <u>Twin Towers</u> and <u>The Pentagon</u>.

3rd: Doesn't look like they were planting any bombs.




All I have to do is a google search and I solved the conspiracy?

I am not dismissing the obvious connections to Israel. I'm simply saying: the media wouldn't give us honest information.



The above image is a scaled down version of the Philadelphia Experiment, re-created by Hutchinson.



An energy weapon is responsible for this.


We also have the power outage at the Burger King in the Evan Fairbanks Footage.

We saw some type of optical illusion / energy weapon at the Pentagon, in Shanksville, and New York City.





Stephen De'ak was born in Hungary in 1897, and died in California in 1975. He grew up in a musical family. When De'ak was seven he started cello lessons, and entered the Royal Academy of Music at the age of eleven.
